**DATA PROCESSING PLACE**

The processing operations connected to the web services of this site take place at the aforementioned headquarters in [Pisa \(PI\)](#) and are only handled by [Hotel Galilei Pisa](https://www.hotelgalileipisa.it) technical staff, or by persons in charge of occasional maintenance operations designated by [Hotel Galilei Pisa](https://www.hotelgalileipisa.it)

**TYPES OF DATA PROCESSED**

- ***Navigation data***

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified interested parties, but which by their very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes IP addresses or domain names of the computers used by users connecting to the site, the addresses in the Uniform Resource Identifier (URI) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (success, error, etc.) and other parameters relating to the operating system and the user's computer environment. These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing.

- ***Data provided voluntarily by the user***

The optional, explicit and voluntary sending of e-mails to the addresses indicated on this site entails the subsequent acquisition of the sender's address, necessary to respond to requests, as well as any other personal data included in the message.

**COOKIES**

No personal data of users is acquired by the site in this regard.

This site uses technical cookies, that is navigation or session cookies and strictly necessary for the operation of the site or to allow the user to take advantage of the contents and services requested by them. Analytics cookies, which allow you to understand how the site is used by users. With these cookies we do not collect information about the user's identity or any personal data. The information is treated in aggregate and anonymous form. Functionality cookies, that is cookies that allow the user to browse according to a series of selected criteria (for example, the language, the products selected for purchase) in order to improve the service rendered. Third-party cookies, that is cookies of sites or web servers other

We do not use cookies to transmit information of a personal nature, nor are used c.d. persistent cookies of any kind, or systems for tracking users. The cookies session are not used (which are not stored permanently on the user's computer and disappear when the browser is closed).

Specific security measures are observed to prevent data loss, illicit or incorrect use and unauthorized access.
